

RESOLUTION NO. 2021-01

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF LAKE CLARKE SHORES, FLORIDA, APPROVING A FISCAL YEAR 2021 SPECIAL APPROPRIATION REQUEST OF \$1,000,000 TO THE STATE OF FLORIDA FOR THE TOWN SEPTIC TO SEWER DESIGN PROJECT AND MATCHING THE APPROPRIATION WITH \$1,000,000 IN TOWN FUNDS; AUTHORIZING TOWN STAFF TO REQUEST AND OBTAIN THE SPECIAL APPROPRIATION BY SIGNING ANY RELATED DOCUMENTATION AND WORKING WITH REPRESENTATIVE DAVID SILVERS; PROVIDING FOR A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the Town of Lake Clarke Shores is working with engineering consultants to survey the area covered by the sewer conversion project, design a central municipal sewer system and prepare a complete set of construction documents to convert septic tanks of approximately 700 residential properties and 25 commercial properties to a central municipal sewer system; and

WHEREAS, in 2019, the State of Florida appropriated \$300,000 towards the Lake Clarke Shores Septic to Sewer Design Project to pay for the survey; and

WHEREAS, the Town desires to obtain additional special appropriation of \$1,000,000 from the State of Florida and match such amount with Town funds to pursue its sewer conversion project.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LAKE CLARKE SHORES, FLORIDA AS FOLLOWS:

SECTION 1. The Town Council hereby approves a fiscal year 2021 special appropriation request of \$1,000,000 to the State of Florida for the Town septic to sewer design project and match the appropriation with \$1,000,000 in Town funds.

SECTION 2. The Town Council hereby authorizes Town staff to request and obtain the special appropriation by signing any related documentation and working with Representative David Silvers.

SECTION 3. If any section, paragraph, sentence, clause, phrase or word of this Resolution is for any reason held by a court of competent jurisdiction to be unconstitutional, inoperative, or void, such holding shall not affect the remainder of the Resolution.

SECTION 4. This Resolution will take effect immediately upon adoption.
