

**RESOLUTION NO. 2021-15**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF LAKE CLARKE SHORES, FLORIDA APPOINTING MEMBERS TO THE PARKS AND RECREATION ADVISORY COMMITTEE; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.**

WHEREAS, in 2013, the Town Council of the Town of Lake Clarke Shores determined that it was in the best interest of the health, safety and welfare of the residents of the Town of Lake Clarke Shores to reestablish the Parks and Recreation Advisory Committee for the purpose of advising and recommending to the Town Council plans, suggestions and recommendations for the improvement, modification and use of municipally owned parks and recreational property of the Town; and

WHEREAS, Rene Connors has expressed an interest to remain a member of the Parks and Recreation Advisory Committee; and

WHEREAS, Jennifer Chrzanowski, whose three year term on the Parks and Recreation Advisory Committee expired in May of 2020 will remain a member of the Parks and Recreation Advisory Committee.

NOW, THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LAKE CLARKE SHORES, FLORIDA, AS FOLLOWS:

SECTION 1. The meetings of the Parks and Recreation Advisory Committee shall be public meetings subject to the Florida Government in the Sunshine Laws, provided however that the members of the Parks and Recreation Advisory Committee shall not be required to file financial disclosure forms as a result of being a member of said Committee.

SECTION 2. Rene Connors has been reappointed to serve as a member of the Parks and Recreation Advisory Committee for a three year term that will expire in May 2024.

SECTION 3. Jennifer Chrzanowski has been reappointed to serve as a member of the Parks and Recreation Committee for the remaining two years of her three year term that will expire in May 2023.

SECTION 4. The above named individuals shall carry out the duties and functions of the Parks and Recreation Advisory Committee as outlined in Chapter 38 Article II of the Town Code of Ordinances.

SECTION 5. This Resolution shall be effective immediately upon adoption.
