ORDINANCE 2022-02

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF LAKE CLARKE SHORES, FLORIDA, AMENDING CHAPTER 30-MISCELLANEOUS PROVISIONS AND OFFENSES, ARTICLE I. IN GENERAL, SECTION 30-3. - DAMAGE TO KELLER ROAD TRAFFIC CONTROL STRUCTURE, TO DELETE THE INTENTION TO DAMAGE THE KELLER ROAD TRAFFIC CONTROL STRUCTURE; PROVIDING AUTHORITY TO CODIFY; PROVIDING A CONFLICTS CLAUSE, SEVERABILITY CLAUSE, AND AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LAKE CLARKE SHORES, FLORIDA, AS FOLLOWS:

SECTION 1. Section 30-3. – Damage to Keller Road Traffic Control Structure of Article I. In General of Chapter 30 – Miscellaneous Provisions and Offenses of the Code of Ordinances of the Town of Lake Clarke Shores, Florida is hereby amended to read as follows:

Sec. 30-3. - Damage to Keller Road traffic control structure.

It shall be unlawful and a violation of this Code for any person to willfully or intentionally deface, damage or alter any portion of the Keller Road traffic control structure and appurtenances thereto, including, but not limited to, the gate and the control box. Any person found to be in violation of this section will be punished as provided in section 1-11.

SECTION 2. The provisions of this Ordinance shall be made a part of the Code of Ordinances of the Town of Lake Clarke Shores, Florida. The sections of this Ordinance and of the Code of Ordinances may be renumbered or lettered to accomplish such, and the word "ordinance" may be changed to "section," "article," or any other appropriate word.

SECTION 3. All Ordinances or parts of Ordinances, and all Resolutions or parts of Resolutions, in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4. If any section, paragraph, sentence, clause, phrase or word of this Ordinance is for any reason held by a court of competent jurisdiction to be unconstitutional, inoperative, or void, such holding shall not affect the remainder of the Ordinance.
