#### 2. PRESENTATION OF PROPOSED 2019/2020 TOWN BUDGET

A) Dan Clark, Town Administrator

Mr. Clark noted that four funds will be discussed. He provided the following information on each fund

General Fund –

- Millage Rate to remain the same for the 10<sup>th</sup> year at 6.2798.
- Taxable values are up 6.49%.
- Expenditures are 2% less than last year.
- CPI is up 1% with merit increases of 2.8%.
- Capital improvements include boat cover for police boat and tennis court fencing.
- 8 Leased vehicles will be received this fiscal year.

Surtax Fund –

• Anticipated revenue of \$241,000.

- Expenditures are lower than last year due to road repaving projects put on hold until after sewer impact has been decided.
- Storm drain improvements will be done at various locations.
- Pine Tree Bridge plans still ongoing.

CRA –

- Estimated \$46,500 combined TIF revenue from PBC and Town.
- Tax base within CRA has increased 28% since CRA base value was first established in 2016.
- Hiring a Consulting Financial Advisor to review future CRA Funding options.
- Median improvements and Business Development Incentive Projects will continue.

Utility Fund –

- Will hire one additional employee.
- Up to 2.8% merit increases.
- New Rate Study included in budget.
- Update to 10 year capital improvement plan.
- Capital improvements include Munis upgrade, new vehicle and standby pump.
