1. Call to Order

A. Roll Call

B. Moment of Silence, Pledge of Allegiance, Invocation – (moved from Regular Town Council Agenda)

Mayor Rodriguez requested a moment of silence for the 200,000+ people who have died from COVID-19. Pastor Hunter, Pastor of Emmanuel Baptist Church, gave the invocation, then led the Pledge of Allegiance.

2. Second Public Hearing 2020/2021 Town Budget

A. Presentation of 2020/2021 Budget - Daniel Clark, Town Manager

Mr. Clark noted that the budget has not changed much since the July Budget Workshop. He noted the following information:

- General Fund Revenue is off by 13% due to sales tax revenue losses from the impacts of COVID-19.
- Garbage collection services increased 10%

Mr. Clark noted the core missions of the Town. He also noted the following information for the general budget:

- Limited Capital Expenditures in the General Fund
- No new vehicles this year for General Fund
- Limited Parks and Recreation expenditures
- Limited special events for remainder of the year due to COVID-19 guidelines
- No change in the Millage Rate. Keeping at 6.2798

- Roll back rate of 6.0388
- Current taxable values are up 4.33%
- Up to 3% merit increase, with no change in benefits.
- CPI is down 0.2%
- Capital Budget amount of \$6,000 for road striping

Infrastructure Surtax Fund:

- Unbalanced budget due to construction of Pine Tree Bridge
- Debt Service loan for bridge construction costs

CRA Fund:

- Estimated PBC TIF Contribution of \$28,500
- Estimated LCS TIF Contribution of \$37,400
- Planned expenditures of \$64,000 include new 2 new beautification programs and additional money into Business Incentive Program

Utility Fund:

- Unbalanced budget due to construction projects
- Up to 3% salary increase, with no change in benefits
- No new Debt Service
- New initiatives include:
 - Finish and implement Rate Study
 - New 12-inch water main
 - New Utility Administrative Building
- Capital Budget includes:
 - 2 new leased vehicles
 - Upgrade 2 lift stations
 - Build Lawrence Road 12-inch water main
 - Construct new Utility Administrative Building
