MINUTES TOWN OF LAKE CLARKE SHORES SECOND PUBLIC HEARING 2021/2022 TOWN BUDGET SEPTEMBER 28, 2021 6:30 PM

1. Call to Order

A. Roll Call

Mayor Paul R. Shalhoub called the meeting to order at 6:30 p.m.

The following officials were present:

Paul R. Shalhoub, Mayor Robert M. W. Shalhoub, Vice Mayor Gregory Freebold, President Pro Tem Valentin Rodriguez, Jr., Council Member Albert Pavon, Council Member

B. Moment of Silence, Invocation, Pledge of Allegiance (moved from Regular Town Council Agenda)

Pastor Stan Sniezek, Pastor of the New Life Alliance Church, gave the invocation, then led the Pledge of Allegiance.

2. Presentation of Proposed 2021/2022 Town Budget

A. Daniel Clark, Town Manager

Mr. Clark noted this is the eleventh budget that he has prepared and that this one was the most challenging. He noted the following information within the five funds included in budget:

General Budget:

- Limited Capital expenditures with a budget of \$13,500
- Events have been put back into the budget
- Balance budget with no change in the millage rate of 6.2798 which is 5.06% higher than the roll back rate of 5.9775
- Up to 3.5% merit increase to meet CBA contract requirements
- Increase of 3% in garbage collection services

Utility Fund:

- Replacing two Town vehicles with leased vehicles
- Will finish the Rate Study, 12' water main project and the new Utility Administration Building
- Capital Budget includes:
 - Engineering for MICA West

- Widening of Lawrence Road
- 12-inch water main
- Unbalanced at this time

Infrastructure Surtax Fund:

- Estimated revenue of \$226,000
- Expenditures in the amount of \$1,120,169 include:
 - Drainage repairs
 - Road maintenance
 - Bridge construction that was delayed to 2022
- Bridge design has been completed. Town will be going out for bids in November
- Estimated carry forward of \$320,056

CRA Fund:

- Estimated PBC TIF Contribution of \$30,860
- Estimated LCS TIF Contribution of \$40,530
- Planned expenditures of \$72,000 for beautification programs and Business Incentive Program

ARPA Fund:

Mr. Clark noted the Town received \$908,298 for this year's portion of the ARPA. He noted that the Town is very limited on what can be done with the money.

He noted the following projects for the ARPA Fund:

- Lawrence Road utility relocation
- Support for the Utility Administration Building

3. Council Comments

Mayor Rodriguez – asked Mr. Clark about the ARPA and Surtax funds that have been received. Mr. Clark noted that ARPA funds have been used to upgrade the Town's servers and software. The Infrastructure Surtax money has been used for roadway maintenance for the past three years. Roadways will continue to be repaved in sections over the next few years using the Infrastructure monies.

President Pro Tem Freebold – noted the limited amount available for Parks and Recreation. He also noted that he likes the new budget layout.

Council Member Pavon – did not have any comments or questions at this time.

Vice Mayor Shalhoub – noted that Mr. Clark did a great job on the budget this year.
