American Rescue Plan (ARP)

The latest guidance from Treasury came in the form of Frequently Asked Questions (FAQ's) and answers (35 pages) dated 6/24/2021. Lake Clarke Shores is identified as a Non-Entitled Unit of government (NEU) and will get our allocation of funds from the State of Florida. We have met the criteria for disbursement as it has been explained to us, but the State has asked Treasury for an extension to the disbursement timeline in the Interim Final Rule. It is expected the State will ask for a second 30-day extension, so it could be mid-August before the monies are disbursed. We have not heard if the allocation has changed or if they are updating the distributions to match the 2020 Census data. Fifty percent of the allocation will come in FY2021 and the other 50% will come in FY2022. We have four years to encumber the funds and six years to spend the monies.

FY2022 Budget

We have prepared a DRAFT 2022 Budget for presentation during the July 13th Budget Workshop. We are planning for fewer sales tax and business tax revenues that we have had in the past years so we are limited in what we can do again this year. In the General Fund Budget, we are planning to return to a near normal events schedule starting with the Holiday Parade and the Holiday Tree Lighting on December 4th. In the Infrastructure Fund Budget, we are planning more road repaving, drainage improvements, and construction of the Pine Tree Lane Bridge (delayed from 2021).

In the CRA Budget, we are planning the construction of a septic-to-sewer conversion project for 1475 Forest Hill Boulevard. This project qualified for a \$224,882 CDBG grant from Palm Beach County. Other improvements include continuing the building beautification project and an expansion of the redevelopment advocacy program.

In the Utility Fund Budget, we are planning on completing several major capital projects such as the 12-inch watermain project, the Utility Admin building, our portion of the widening of Lawrence Road, several pipeline repairs and the design of the sewer system for Mediterranean, Indian, Caribbean, and Arabian West as well as the connecting streets.

2021 Florida Legislature House Bill 1059

The Governor signed HB 1059 into law. We now have an unfunded mandate to convert our permitting system to an all-electronic system by October 1, 2021. We have reviewed several vendors' products and have settled on a cloud-based system called MyGovernmentOnline (MGO). It is robust, straight forward and relatively affordable. Several of our neighbors currently use it like Juno Beach, Jupiter Inlet Colony, and Palm Beach Shores. An important part of the MGO electronic process is the cloud-based review comments and inspector comments. These comments are available to the owner/contractor immediately when completed. Inspections are scheduled by the owner/contractor on line at their convenience. MGO is attempting to determine what it will take to import our existing data out of IMS and then will give us a price for importing that legacy data. We hope to be able to come to an agreement with them by the middle of July and then start the implementation/training/transition process.

2021 FRDAP Grant

The Pickleball FRDAP grant process is continuing. The sole purpose meeting was held on June 17th. Comments were received. The Parks and Recreation Committee will have its last Pickleball planning meeting on July 29th. It is expected they will approve the plan and transmit it to the Town Council for comment and approval. Then, the Grant application can be completed.
