# 9. Application

ZBA 2021-02

Nicholas Octavi & Samantha Gallegos 7432 Pine Tree Lane Lake Clarke Shores, FL 33406

Applicant is requesting 2.5' side variance to construct a single car garage that will be 7.5' from the side property line with relief from the 10' side setback as required in Sec. 125-295 (2) of the Town's Code of Ordinances.

Mr. Octavi noted that they need 12 feet, at least, to fit their car in the garage, current garage is not 12 feet and car does not fit. Mr. Octavi said he is only asking for what is needed and nothing extra. Space is for a one car garage. The garage will be extended towards the back of the property so they would not exhaust the request. The current garage will be used as a storage since it cannot fit their car. Mr. Octavi will have garage match to make it look like it is part of the house.

Mr. Palacios, Zoning Official, noted that the neighbor across the street stated they had no issue and that neighbor stated the neighbor next to the home also had no issue. Mr. Palacios also noted that staff has no recommendation at this time.

Board members asked if there were any utility easements in the way. They asked if the current garage would remain or be opened, homeowner stated it would remain closed. Board asked if landscaping was being removed as it will be a good buffer to keep it, homeowner said landscaping will remain and keep it consistent. Board member asked if same roofing system will be used, homeowner said yes.
