1. **ZBA 2023-03**

Donald and Sherry Swinarski 7114 Venetian Way Lake Clarke Shores, FL 33406

The Applicants are requesting an 8' rear variance to build a swimming pool 2' from the rear property line with relief from the 10' setback as required in Sec.125.891 (a) of the Town Code of Ordinances.

Mr. Swinarski noted that due to the size of the lot and there is a 10' setback with a large 75ft South Florida Water Management Department that extends to the C-1 canal and that many residences that are along that road and canal have been granted variances. The (S.F.W.M.D.) also has no issues with the location of the pool.
